- Proof of residency is required with this application
- Candidates must be a graduating high school senior
- Candidate must have at least a weighted 3.0 grade point average, proof provided with this application
- Candidate must be accepted at a 2 or 4 year accredited college, university, or vocational school, proof must be provided with application
- The award will be made without regard to financial need
